<p>4 4.1 4.2 4.3 4.4 4.5</p>	<p>Enterprise Zones review</p> <p>A lot of activity is happening with regard to the Devolution Deal for Cornwall, Shared Prosperity Fund (SPF) and changes to the LEP. This Board would like to take forward a cluster consisting of Aerospace/Space, FLOW, Tech metals and Farming, Fishing and Food.</p> <p>There has to be coordination with SPF governance, as there is a Strategic Sector Support Advisory Panel. More private investment will be encouraged, to drive growth forward, particularly in the green energy sector.</p> <p>Action – GC-G and Claire Hurley to be invited to the next Board meeting.</p> <p>SJ has already had conversations with Claire Hurley who is the SPF manager. It was recognised the importance of keeping a strong link with the LEP Employment and Skills Board.</p> <p>A workshop will be arranged in January 2023 to progress a sector-led cluster which will look at what support is needed to make the model successful. Invitees to include representation from SPF, local Councillors, FLOW and GC-G. The outcome of the workshop will then be shared with CC Executive.</p> <p><i>DJ left the meeting at 16:03.</i></p>	<p>CC</p> <p>SJ</p>
<p>5 5.1</p>	<p>Spaceport update</p> <p>GE visited the Centre for Space Technology in November 2022 and others can visit too. The lease for the Space Systems Operations Facility co-working area is currently being processed and should be finalised shortly. There have been a few Expressions of Interest (Eoi).</p>	

5.2	The recent launch event was an opportunity for positive press to showcase Cornwall as a credible centre for Space.	
5.3	A bid for SPF will be submitted for a feasibility study for phase 3 R&D centre. Eols will be requested, Cornwall has been awarded £5m from UKSA with a draw down deadline date of March 2025.	
5.4	The Kernow Sat recruitment is underway and a manager is expected to be appointed shortly. The Space Cluster activities will continue to expand growth in the sector. The launch of Cosmic Girl will take place after Christmas 2022.	
5.5	The Aerospace Cluster is looking to set up a supply chain at Culdrose to support the mail drone activity at Predannack Airfield. In partnership with Innovate UK, Royal Mail, NHS and MOD, flight paths will be created and a test flight arranged.	
5.6	The mail drone has connectivity benefits for areas which are difficult to reach, particularly for delivering NHS supplies. There has been interest from local potential clients already. The possibility of using CAN will be explored.	
5.7	Action – GE to write a paper on the proposal, copy in SJ and speak to Cllr Gardner.	GE

6a	Aerohub	
6a.1	Currently, letting activity has slowed down; the exclusivity agreement with Blue Abyss has expired. The interest from Blue Abyss remains strong. Proof of funds will be needed if the Board is to agree reinstatement of their preferred position.	
6a.2	Conversations with Treveth are underway regarding developing on sector 3 and 4.	
6b	Goonhilly Earth Station	

6b.1	GES has had good success on Artemis, providing support to NASA for Orion and multiple cubesats. Starting from January 2023, GES will provide 24/7 support to ESA/NASA spacecraft.	
6b.2	More antennas are required to support the lunar and deep space markets, with this infrastructure supporting growth at Goonhilly. GES, alongside Spaceport's rising profile, is enabling Cornwall to be recognised as a leader in the space sector.	
6b.3	GES and CAN are well placed to capture resulting business growth in the space sector, noting the requirements for suitable working space and living accommodation. PT offered GES facilities for a workshop.

7a.1	The port development project is continuing with stakeholder discussions and design reviews. An Environmental Impact Assessment will be undertaken.	
7a.2	The rail head connection conversations are ongoing with Network Rail and Cornwall Council.
